1. AIM AND SCOPE

本课程旨在向学生介绍亚里士多德的心灵哲学，即他围绕灵魂的讨论以及相关话题。学生将学习如何在当代语境下阅读、理解以及评价亚里士多德的心灵理论，尤其是他对知觉、思想、欲望和情感等心灵状态的看法。我们将通读《论灵魂》(*de Anima*)的主体部分，同时辅助其他相关文本（例如《自然诸短篇》《形而上学》和生物学著作等）。在细读全文的基础上，我们将讨论的话题包括但不限于形质论、灵魂的本质和划分、感官知觉的本质、认知能力、欲望、常识和幻觉。其他古代作者和古代评论家材料也会参与者的兴趣和要求加以考虑。当然，近期学术界对亚里士多德心灵哲学的争论也会有所涉及。本课程的前提是具备古希腊哲学，尤其是亚里士多德哲学的基础知识。古希腊语不是课程的必要条件，但我们要求学生阅读英文翻译和相关的二手文献。

This seminar is designed to introduce students to Aristotle's philosophy of mind. Students will learn how to read, interpret, and evaluate Aristotle's psychology and related topics, particularly his view on perception, broadly understood. We will work through the main body of the *De Anima*. Through close reading of the text, we will discuss topics including, but not limited to, hylomorphism, the nature and division of the soul, the nature of sense perception, cognitive capacities, desire, common sense, and *phantasia*. Relevant sources from Aristotle and other ancient authors will also be explored selectively. Ancient commentators may be considered depending on the interests and requirements of the students. Additionally, recent scholarly debates on Aristotle's theory of mind will be addressed. This course presupposes basic knowledge of ancient philosophy, especially Aristotle. Although knowledge of ancient Greek is not required, students are encouraged to engage with English translations and research literature.

This seminar aims to:

- provide a general introduction to Aristotle's psychology, along with a survey, analysis, and assessment of many related topics;
- explore key issues in the *De Anima* (perception, desire, *phantasia*, the mind-body problem, etc.) with historical and critical depth;
- demonstrate Aristotle's significant influence in late antiquity, particularly within the ancient tradition of commentators;
- reveal the philosophical richness of Aristotle's thought and its contribution to, or provocation of, contemporary philosophy;
- introduce students to currently available tools for studying Aristotle and ancient philosophy;
- provide students with the opportunity to develop and enhance their skills in analysis, presentation, and writing within the field of ancient philosophy.

Students will:

- identify and explain the philosophical vocabulary of Aristotle's philosophy of mind;
- utilize professional resources and bibliographical tools;
- explicate and assess key philosophical doctrines of the *De Anima*, particularly concerning the nature of perception;
- understand Aristotle's psychology within its historical and cultural context, as well as some central features of its reception and transformation in later periods;
- critically analyze the cogency of philosophical arguments on central issues.
